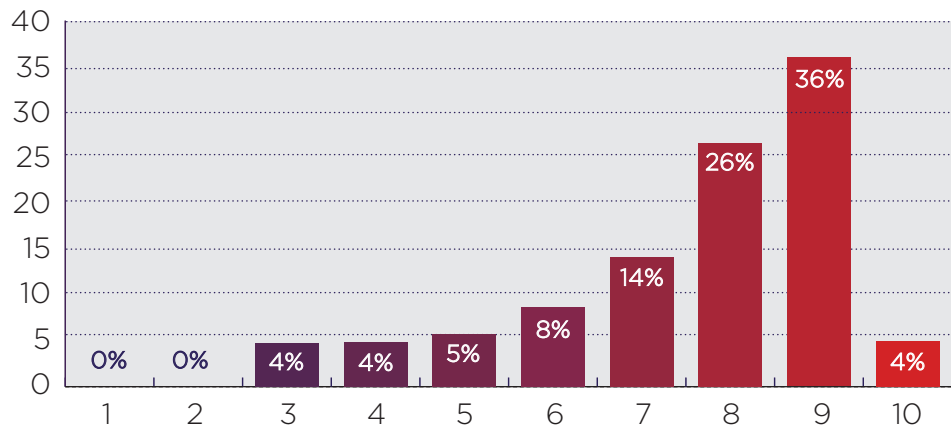


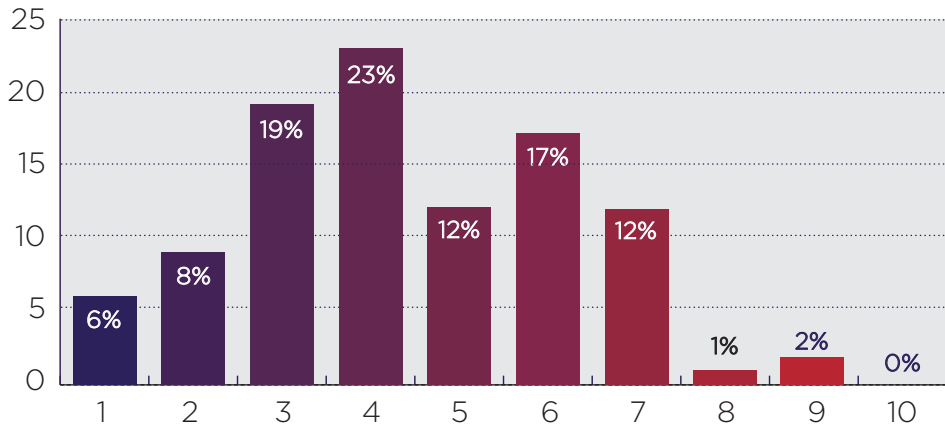
How likely do you think it is that **the UK will leave the EU** on 29 March 2019?

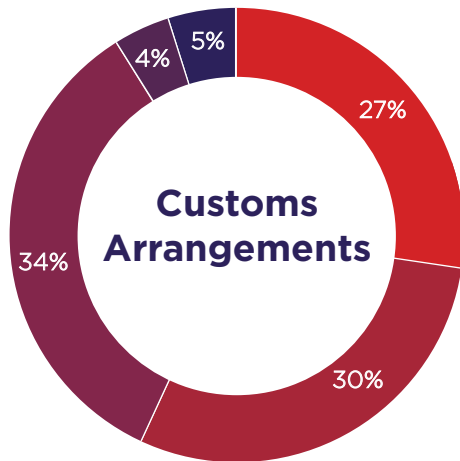
How likely do you think it is that the **UK will leave the EU with no deal?**

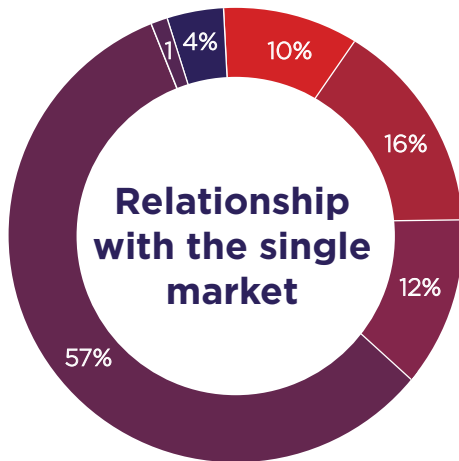
Which of these **customs arrangements** is most likely to be agreed between the UK and the EU after the end of any Brexit transition period?

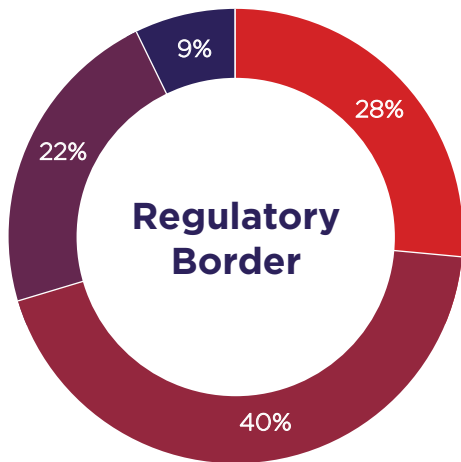

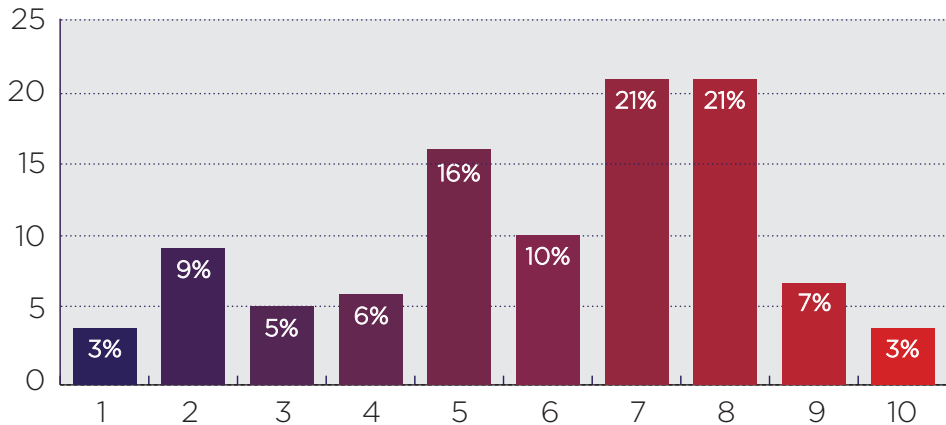

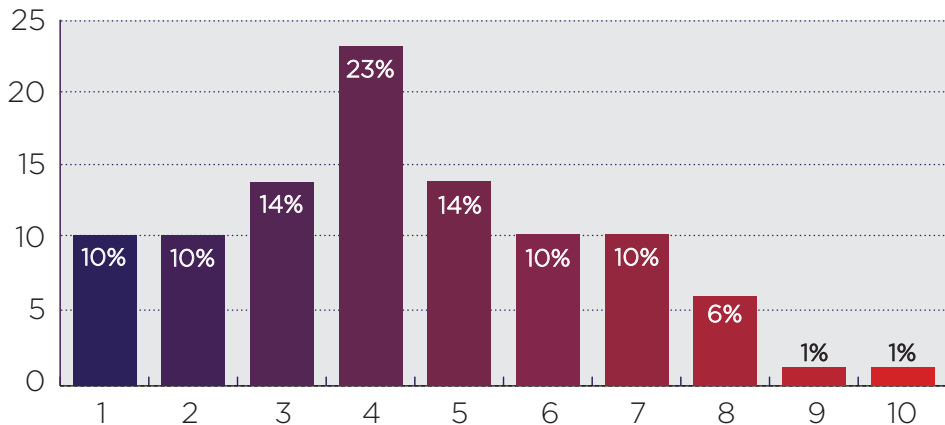
How likely do you think it is that the **transition period will be extended** beyond its current date of December 2020?

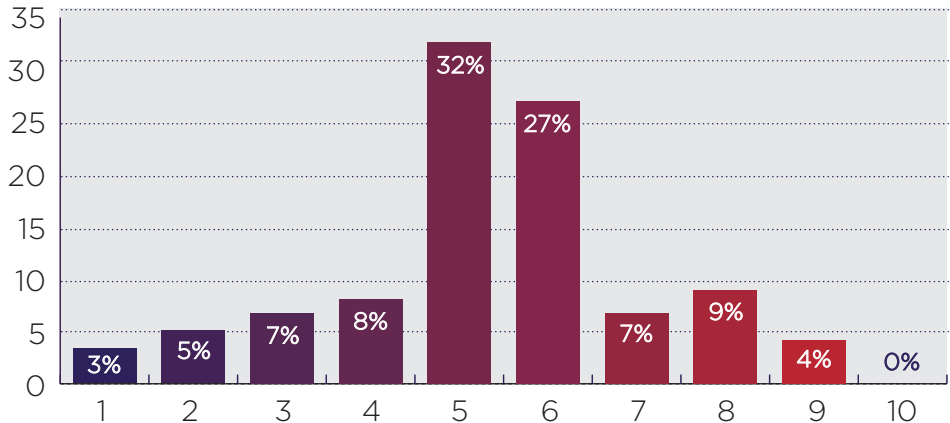
How likely do you think it is that the **Article 50 period will be extended?**

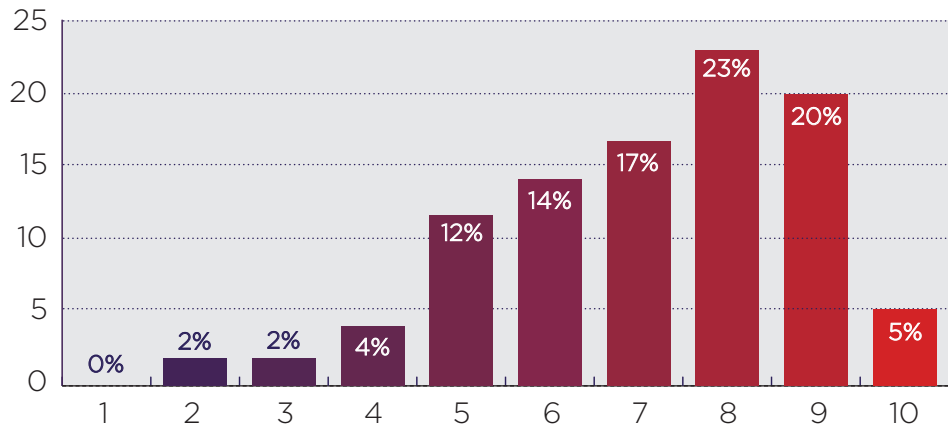
On a 1-10 scale, how likely is it that the **Brexit deal will be passed by the UK parliament?**

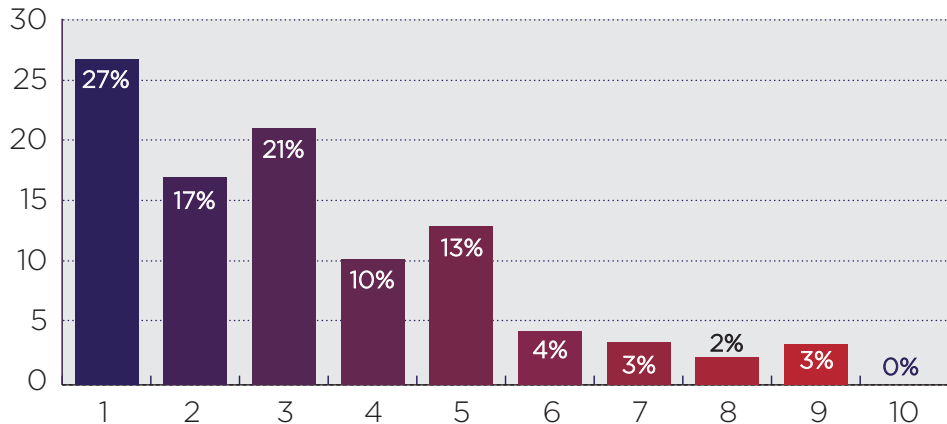
On a 1-10 scale, how likely is it that the **Brexit deal will be passed by the European parliament?**

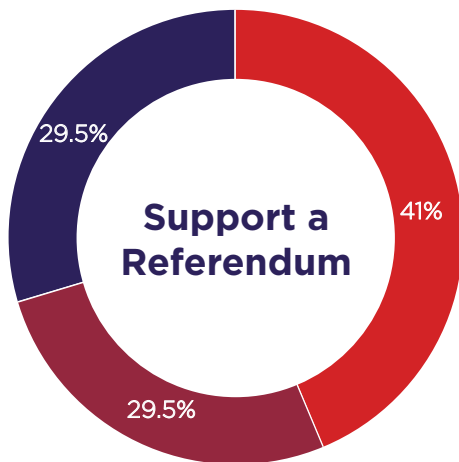
How likely do you think it is the UK will hold another referendum on EU membership before 29 March 2019?

Do you think the Labour party is likely to come out in **support of a referendum on the UK's negotiated deal** with the EU before 29 March 2019?

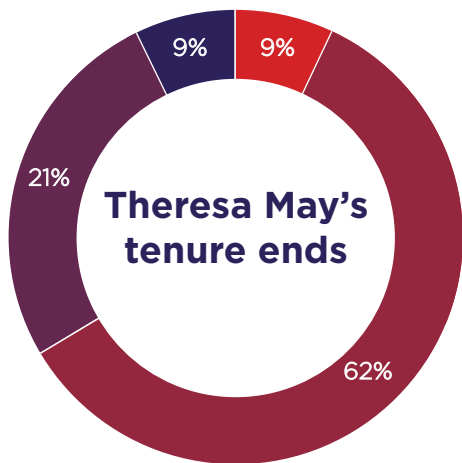

When do you think it is likely that **Theresa May's tenure** of leader of the Conservative Party **will end?**

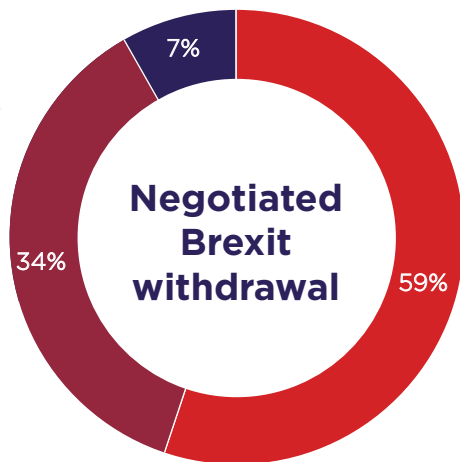

What do you think was the **impact of the Salzburg summit** of EU heads of state and government, on the likelihood of a **negotiated Brexit withdrawal agreement?**

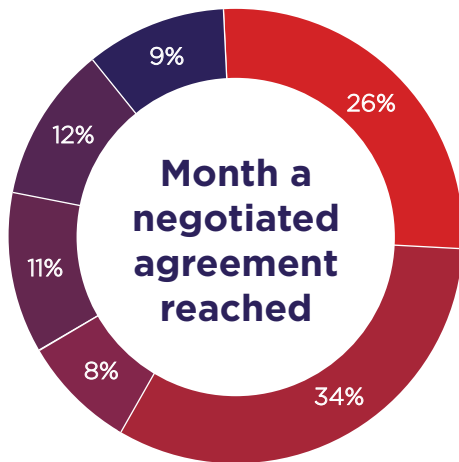
